SB 276 Study Assignment Focus #1:

Obliterating the Hippocratic Oath

LOS ANGELES—As part of the “study assignment” California lawmakers are receiving from a coalition of organizations fighting against Senate Bill 276 to ensure they are educated about the inevitability of vaccine injuries and deaths, Conscience Coalition, a nonpartisan nonprofit, calls on all elected representatives of the people of California to pay close attention to the bill’s assault on the Hippocratic Oath, one of the oldest binding documents in history.

The Hippocratic Oath is a cornerstone of medicine that has for thousands of years guided and regulated the professional conduct of medical doctors. Consistent with the Hippocratic Oath, physicians have historically recognized responsibility to patients first and foremost.

But SB 276 will obliterate its sacred principles by effectively eliminating the ability of doctors to grant medical exemptions to children—that they know by their professional education and training should not get certain vaccines—to children who need exemptions based on their medical and family history, including those who already suffered severe reactions to mandated vaccines. To name some of the reactions that will not be considered under SB 276: seizures, nerve injuries, spinal cord paralysis, autoimmune reactions, bleeding problems, severe gastrointestinal reactions.

Congress passed the National Childhood Vaccine Injury Act (NCVIA) because serious injuries and deaths are inevitably created by vaccines that cannot be made safe, and drug companies threatened to stop making them if they had to continue to face the massive increase in lawsuits from the parents of tens of thousands of victims they were creating.

Eliminating the ability of doctors to grant medical exemptions is the height of insanity.

Conscience Coalition Executive Director Jonathan Lockwood released the following statement:

“Sen. Pan, Assemblywoman Gonzalez and the special interests they are serving are attempting to kill all medically-necessary exemptions from mandated vaccinations. The extremist proponents of this bill are trying to force doctors to violate the Hippocratic Oath and in doing so are opening up doctors to medical malpractice lawsuits. They are ignoring federal law, defying the Supreme Court’s 2011 ruling, and trashing Justice Sotomayor’s vigorous defense of the vaccine injured and killed. Every lawmaker and Gov. Gavin Newsom should beware that if they put their stamp of approval on this bill they are putting their names on the injury and death sentences of vulnerable children.”
